



**DETAILED RE-ADVERTISEMENT FOR PRE-QUALIFICATION OF PROSPECTIVE BIDDERS**

**DESCRIPTION OF WORK**

Seismic correction to the eleven (11) story NPI (Neuropsychiatric Institute) tower. Seismic correction work includes structural strengthening by upgrading and expanding selected existing shear walls and their associated footings; adding 4 new shear walls in plane with the tower's exterior walls and enlarging and strengthening adjacent existing column footings for their use. Selected additional strengthening via Fiber Reinforced Polymer (FRP) wrapping or bolting of structural elements, plus the selective use of steel bracing and drag struts.

Fire Life Safety correction work includes code compliant upgrade of the existing vertical wet standpipe system and removal and put-back of existing fire suppression and fire alarm system elements impacted by the seismic work.

The scope of work to complete the seismic corrections and non-structural upgrades will include selective demolition, storage as necessary, replacement and repair of building systems, elements, and finishes obstructing the proposed work. Additional work includes the abatement of hazardous materials, exterior brick and masonry repair, and code upgrades to existing door hardware, exit stairs, drinking fountains and toilet facilities.

The building will remain occupied and operational during construction and require the coordination (by CM/Contractor) and staging (by others) of occupants. All work will be sequenced and phased and much of the interior work will be performed off-hours.

The anticipated contract value is: \$26,000,000.00

Subject to the conditions in the RFQ and bid documents, prospective bidders for the bid packages (BPs) listed herein are required to prequalify to participate in the bidding process. In addition, pre-qualified prospective bidders will be required to possess the current and active California State Contractor's License as identified below, at the RFQ and Bid due date and time, as designated:

**PRE-QUALIFICATION PASS/FAIL CRITERIA**

1. Hold a current and active BP specific Contractor License in the State of California.
2. Have completed (within the 2013-2017 calendar years) at least one (1) project where the Work performed was applicable to the license(s) specified for the respective Bid Package and where the value of said work was equal to or greater than the respective Estimated BP values specified herein.
3. Have average construction revenue of greater than three (3) times the published BP specific value(s) over the most recent three (3) fiscal years.
4. Have single project bonding capacity greater than published BP specific value as confirmed by a Surety Company licensed through the California Department of Insurance with a rating, as found in A.M. Best, of A or better.
5. Have asset to liability ratio for the 2017 (or 2016 if 2017 financial statements are not yet available for review) fiscal year that is greater than or equal to one (1.00)
6. Have a safety record meeting the minimum OSHA qualifications for enrollment in the UCIP.
7. Have instituted a corporate Injury and Illness Prevention Program in compliance with California OSHA Title 8, Section 3203 requirements.
8. Firm has not been disbarred, terminated for cause or otherwise prevented from bidding on, or completing any public agency project at any time within the last seven (7) years.
9. Firm has not been subject to a disciplinary proceeding by a public agency as the result of a crime for which an owner or officer was convicted, or of a disciplinary infraction such as a breach of a code of ethics, at any time within the last seven (7) years.
10. Firm has not been found in a final decision of a court to have submitted a false claim to a public agency within the last seven (7) years.
11. Firm(s) has not had a surety company perform any or all of their work on one or more of their construction projects within the last seven (7) years.
12. Firm dispatches apprentices from a California Apprenticeship Council approved program for use on any public work project awarded a contract by a Public Entity.
13. Firm meets all Bid Package specific Qualifications as identified.
14. Submission of a declaration that all information provided is true and correct.

15. Submit an Appendix A Project Data Sheets for 3 Comparable/Largest Projects completed within the last seven (7) years for each BP of interest. Scope of Work performed on Comparable Project must be applicable to the license(s) specified for the respective Bid Package.

- a. Subject to the above qualifications, Rudolph and Sletten, Inc. consider the following criteria to define a "Comparable/Largest" project. At a minimum at least five (5) of the following items i-ix must be met and contain current contact information of applicable references (General Contractor, Owner and/or Architect). If Rudolph and Sletten, Inc is unable, after reasonable efforts, to confirm the past project information submitted by prospective bidders, said project may not be accepted. The work in the listed projects must have been managed and constructed by the licensed entity submitting for pre-qualification and performed by the licensed entity's own workforce. Entity may not use experience performed by a parent company, a sister subsidiary company, or a subsidiary to Entity. Additionally, Entity may not use experience where Entity was one member of a separately licensed joint venture Entity.
- i. BP specific construction value at completion greater than or equal to the published BP value per this Advertisement for Pre-qualification.
  - ii. Projects with a total construction cost of \$20 million or greater at time of completion (not the subcontract amount of your trade).
  - iii. Projects built during off-hours.
  - iv. Projects built in the State of California.
  - v. Work having been completed at a College or University campus around an existing fully functional facility.
  - vi. Work being a renovation on a fully operational facility.
  - vii. Work being governed by Public Contracting Code.
  - viii. Project completed at a UCLA campus.
  - ix. Project achieved LEED rating, as certified by the USGBC, or higher.

#### **PRE-QUALIFICATION PROCESS**

R&S has determined that prospective subcontractors for the Bid Packages identified must be pre-qualified to submit a bid for this project. R&S will establish a list of prospective pre-qualified bidders. R&S will determine, solely at their own discretion, whether a prospective bidder is pre-qualified. Each prospective pre-qualified bidder must answer all of the questions and provide all requested information, where applicable. Any prospective pre-qualified bidder failing to do so may be deemed to be not responsive and not responsible with respect to this pre-qualification at the sole discretion of UCLA and Rudolph and Sletten, Inc.

Questions received after that date will be answered at the discretion of R&S. Interested firms are responsible for checking the web site frequently to determine whether any addenda have been published. E-mail is the preferred method for transmittal of questions.

R&S reserves the right, but is under no obligation, to request, receive, and evaluate supplemental information after the indicated time and date at its sole determination. All information submitted for pre-qualification evaluation will be considered official information acquired in confidence, and UCLA and R&S will maintain its confidentiality to the extent permitted by law.

Prospective pre-qualified bidders who request an opportunity will receive a written response containing pre-qualification determination by bid package of interest.

Pre-qualification Questionnaires may not be accepted after the deadline.

If the prospective Subcontractor is determined to not be pre-qualified, the prospective Subcontractor may request a review by R&S. Any such request must be received by the Facility within 3 calendar days after receipt by the prospective Subcontractor of the determination. The decision resulting from such review is final and is not appealable within the University of California. Any person or entity not satisfied with the outcome of the pre-qualification must file a writ challenging the outcome within 10 calendar days from the date of R&S' written notice regarding pre-qualification determination. Any assertion that the outcome of the pre-qualification process was improper will not be a ground for a bid protest.

This project is a public works project and is subject to prevailing wage rate laws (see Contract General Conditions, Article 35.02-c). All contractors and all tiers of subcontractors submitting proposals or bids on this project shall register to bid public works projects with the Department of Industrial Relations, and maintain current this registration pursuant to Labor Code Section 1725.5.
