The building will be LEED[®] certified, targeting a Gold rating. It is a multi-disciplinary research facility that will house a combination of wet laboratories, laboratory support space, and dry computational research laboratories.

CONSTRUCTION DOCUMENTS: The Project plans and specifications are 100% complete.

The work described in the contract is a public work subject to section 1771 of the California Labor Code.
