# PROJECT NOTICE

Subject to the conditions prescribed by the Lawrence Berkeley National Laboratory ("LBNL"), Berkeley, California, which the University of California manages and operates under Prime Contract DE-AC02-05CH11231 with the U.S. Department of Energy ("DOE"), Rudolph and Sletten, Inc. (R&S) (LICENSE # 198069) is soliciting a request for qualifications (RFQ) from including, but not limited to, Lump Sum Pre-Qualified\* Prospective Bidders certified\*\*\* as:

# **INTEGRATIVE GENOMICS BUILDING (IGB) PROJECT AT LBNL**

#### GENERAL SCOPE OF WORK

The IGB is a new building to be constructed on the LBNL site at One Cyclotron Road, Berkeley, California. The building will consist of approximately 81,000 square feet (SF) plus a separate Modular Utility Plant (MUP) of approximately 4,500 square feet (SF). The building will contain both wet and dry laboratory space, office space for researchers and program managers, a computation center, and warm and cold rooms for research.

#### ESTIMATED VALUE AND DURATION

The total estimated value for the construction of both buildings is estimated to be \$70 million. Construction is expected to commence late July 2016, and is expected to continue for a period of 24 months.

This schedule is subject to change prior to the commencement of construction services.

#### PRE-QUALIFICATION OF SPECIALTY TRADE CONTRACTORS

R&S has determined that Prospective Bidders must be Pre-Qualified\*. Pre-qualification will be determined by means of a written questionnaire and additional information which all potential Prospective Pre-Qualified Bidders must complete and submit for evaluation by R&S to establish their qualifications. R&S will establish a list of Pre-Qualified Prospective Bidders. A single firm will be selected for award of each BP described herein. R&S will determine whether a Prospective Bidder is Pre-Qualified.

Each Prospective Pre-Qualified Bidder must answer all of the questions and provide all requested information, where applicable. Any Prospective Pre-Qualified Bidder failing to do so may be deemed to be not responsive and not responsible with respect to this RFQ. All information submitted for prequalification evaluation will be considered official information acquired in confidence, and R&S will maintain its confidentiality to the extent permitted by law. Those Prospective Pre-Qualified Bidders who are not pre-qualified by R&S for this opportunity will receive a written response explaining the decision. The decision is final. R&S anticipates that it will request bids for the following bid packages:

# PRE-QUALIFICATION FACTORS

# The <u>minimum</u> requirements for all Prospective Bidders wishing to submit their pre-qualification documents are:

- A. Hold a current and valid BP specific Contractor License in the State of California as required.
- B. Have (during approximately the last three (3) years) completed at least one (1) project with a final contract value of more than the published BP specific value(s).
- C. Have average construction revenue of greater than three (3) times the published BP specific value(s) over the most recent three (3) fiscal years.
- D. Have single project bonding capacity greater than published BP specific value(s) as confirmed by a reputable Surety Company.
- E. Have asset to liability ratio for the 2015 (or 2014 if 2015 financial statements are not yet available for review) fiscal year is greater than or equal to one (1.00)
- F. Have a satisfactory safety record. LBNL desires that subcontractors have Experience Modification Rates (EMRs) as determined by the CA Workers Compensation Insurance Rating Bureau of 1.0 or less over the last three (3) complete years. Exceptions may be granted. Firms with an EMR of greater than 1.0 in one of the last three years should provide additional information regarding the circumstances that caused the higher EMR. A decision to grant an exception to this requirement is at the sole discretion of R&S.
- G. Have a corporate Injury and Illness Prevention Program in compliance with California OSHA Title 8, Section 3203 requirements.
- H. Prospective Bidders must submit <u>all</u> required information.

Note: Not all questions in the pre-qualification questionnaire are taken into consideration for prequalification; some questions are for informational purposes only.
